RIDE WAIVER AND RELEASE OF LIABILITY

The *Participant* identified below ("*Participant*") will participate in Pedaling for PathStone ("*Event*") coordinated by PathStone Corporation and its affiliate, PathStone Foundation (collectively, ("*PathStone*"). *Participant* or, if applicable, the parent/guardian of *Participant*, acknowledges that this athletic *Event* is an extreme test of a person's physical and mental limits and that while participating in the *Event* that *Participant's* use of public streets and facilities creates a potential for encountering hazards. *Participant*, therefore, acknowledges that there are many risks involved and that accidents may occur during the *Event* that could result in serious bodily injury, or potential death, to *Participant* or others. These risks are not only inherent to athletics but are also present for volunteers.

Furthermore, *Participant* acknowledges and represents that *Participant* is physically fit, does not suffer from any physical or mental impairment which prevents or alters *Participant's* ability to participate safely in the aforementioned *Event*, and has not been advised otherwise by a qualified medical person. *Participant* acknowledges and represents that (s)he has the requisite skill and knowledge to perform all of the functions required in connection with the *Event* and *Participant* understands and agrees that *Participant* is solely responsible for any personal property *Participant* brings or uses while participating in the *Event*.

The *Participant* will abide by all rules and regulations established by PathStone or the *Event* organizers and personnel as well as state and local vehicle codes. *Participant* will wear a properly fitted and adjusted ASTM-, ANSI-, CPSC- or SNELL-certified helmet while riding. *Participant* also acknowledges that his/her participation in the *Event* is subject to the sole discretion of the *Event* organizers and medical personnel and that *Participant's* participation may be limited or terminated for medical or other safety-related reasons.

Participant acknowledges that alcoholic beverages may only be consumed after the conclusion of the *Event* or during the designated rest periods ("*Rest Periods*") associated with the *Event* and will not be supplied by *Event* organizers or PathStone. *Participants* may only partake in the consumption of alcohol if *Participant* presents suitable identification to *Event* organizers that *Participant* is over the legal age of twenty-one (21). *Event* organizers retain the right to limit *Participant's* alcohol consumption and refuse to allow participation in the *Event* if *Participant*, in the sole discretion of the *Event's* organizers or staff, is determined to be unfit to continue. *Participant* will also not provide any alcohol to individuals who are under the legal age of twenty-one (21). Failure to abide by this prohibition will result in immediate removal of *Participant* from any further participation in the *Event*. *Participant* agrees to indemnify and hold PathStone and the *Event* organizer harmless from and against any claims, liabilities or expenses that arise as a result of *Participant's* failure to comply with the terms of this paragraph.

If as a result of *Participant's* participation in the *Event*, *Participant* requires medical attention, this form serves to give *Participant's* consent to the authorized medical personnel of the *Event* to provide such medical care as is deemed advisable by such authorized personnel. *Participant* acknowledges that *Participant* will be financially responsible for the costs of any medical treatment received. *Participant* hereby confirms that *Participant* has adequate medical insurance or will have such insurance at the time of the *Event*.

Participant further understands that if the *Event* cannot be held as scheduled for any reason, the *Event* and PathStone will not be obligated to refund any money paid by or on behalf of *Participant* to participate including, but not limited to, any required or voluntary registration fee. *Participant* understands that *Participant's* registration is not transferable and *Participant's* registration fee is non-refundable.

Participant also acknowledges that there are many risks associated with operating *Participant's* automobile in support of the *Event*. In consideration of PathStone allowing *Participant* to participate in the *Event*, *Participant* agrees to assume all associated risks. *Participant* has already purchased or will purchase and maintain automobile insurance with at least \$1,000,000 coverage for each claim and maintain similar coverage for uninsured/underinsured motorists.

Participant hereby grants permission to PathStone to use photographs, video and/or voice recordings of *Participant* or *Participant's* family in legitimate accounts and promotions of this *Event*.

With the full understanding of the potential risks associated with the *Event*, and in consideration of PathStone allowing *Participant* to participate in the *Event*, *Participant* or, if applicable, *Participant's* parent/guardian hereby agrees, to (a) assume all risk of participation in the *Event*, (b) waive, release, discharge and indemnify PathStone, and its affiliates, directors, officers, employees, volunteers, agents and sponsors, from any and all liability for any injury to person or property (including death) that *Participant* or any third party might suffer as a result of *Participant* participating in or witnessing the *Event*, and (c) not sue any of the above-named parties for any and all liabilities or claims made as a result of participation in the *Event*.

As evidenced by *Participant's* signature, *Participant* certifies that *Participant* has read and understands this Waiver and Release, that *Participant* is at least eighteen (18) years of age, and that *Participant* has signed this Waiver and Release of *Participant's* own free will.
